Coach Parking:	Available at meeting points.
Toilets:	Available at meeting points.
Seating:	The Killarney Jaunting Car can seat 6 – 10 passengers. MV Lily of Killarney Cruise can seat 80 passengers. Traditional Open Boat can seat 12 passengers. Pony and Trap at Gap of Dunloe can seat 4 passengers.
Booking:	All tours must be prebooked by contacting +353 (0)64 6633358 or info@killarneyjauntingcars.com Prebooking is essential to guarantee your preferred time and date. Final numbers and timings must be confirmed 7 days prior to scheduled tour date.
Cancellation:	For all bookings our cancellation policy is seven days prior to tour date. Thereafter the tour will be charged in full. Cancellation due to extraordinary circumstances will be reviewed by the booking team. For any booking made within the above period, a 48 hour cancellation policy (48 hours prior to arrival) will apply. Change of passenger numbers are accepted up to 48 hours without charge.
Methods of Payment:	Vouchers are accepted from tour operators where pre-authorization and credit terms are in place. Payment can be made via Wire Transfer or Irish Bank Cheque.
Clothing:	Warm clothes are advised blankets are supplied to all passengers on the Killarney Jaunting Cars. The Killarney Jaunting Car and The Lily of Killarney Watercoach are covered from the elements. The Traditional Open Boat and Pony and Trap in the Gap of Dunloe are open and appropriate clothing & footwear is advised. Appropriate clothing and footwear is advised for the walking, kayaking and cycling tours. For the Cycling activity try to wear loose comfortable clothes (track suit trousers and fleece are best) and rain jacket if you have one and some sturdy shoes such as trainers or similar (no sandals please).

Participants under 18 must have a parent or supervising adult present to sign for them. Helmets and Hi-Vis jackets are required and are provided by The Bike Tour Company.
Participants must meet this requirement. All participants must be able to ride a conventional bike.
On the Killarney Jaunting Car & Traditional Open Boat to Innisfallen Island this tour can be packaged/ bundled with extras.
i.e. storytelling on the island – any additional activity on the tour will have an extra cost on the above.
